## Terms and conditions of the RAFA 2024 conference

### 1 Applicability

- 1.1 The 11<sup>th</sup> International Symposium on Recent Advances in Food Analysis (RAFA 2024) (hereinafter referred to as "Conference") is organised by the University of Chemistry and Technology, Prague (UCT Prague, Czech Republic) and Wageningen Food Safety Research (WFSR), part of Wageningen University & Research (Wageningen, the Netherlands). All services provided in the context of the Conference will be subject to these Terms and conditions. Making the registration you agree to these Terms and conditions.

### 2 Agreement

- 2.1. Once you have registered for the Conference, you will receive confirmation about your registration by e-mail.

### 3 Cancellation

- 3.1. Only written cancellations can be accepted, to be sent to [RAFA2024@vscht.cz](mailto:RAFA2024@vscht.cz).
- 3.2 Cancellation of participation in the Conference:  
Cancellation before September 1, 2024 – refund 75%;  
no refunds after that date.  
Where an individual fails to attend and has not cancelled in advance, the full Conference costs are also payable.  
It is acceptable to send a substitute to the Conference, but it must be communicated at [RAFA2024@vscht.cz](mailto:RAFA2024@vscht.cz) not later than by October 15, 2024.

### 4 Changes to the program, location of the conference

- 4.1 Where there is good reason to do so, the organizer is entitled to change the location of the Conference. Attendees will then be permitted to withdraw.
- 4.2 Where there is good reason to do so, the Conference may be cancelled; any charges that have already been paid will be refunded. No claims for compensation

above and beyond this will be valid. Irrespective of this, the organizer may cancel the Conference up to 14 days before it starts without giving a reason.

- 4.3 In case of force majeure, neither party may hold the other liable for any delay to or non-performance of the agreement which results from this force majeure.
- 4.4 The organizer reserves the right to make changes to the program at any time.

### 5 Prices and services

- 5.1 The prices quoted in the program cover the services listed in that program. No compensation will be made for any services not accepted in their entirety.

### 6 Liability

- 6.1 The organizers cannot accept any liability for loss or damage of properties, injuries, unexpected events, travel delays, non-appearance of specific speakers, program changes.
